- The AV staff will be available to load your file onto the computer to be used for the sessions from 5:30-6:30 pm on Wednesday, Thursday and Friday evenings, from 6:15-7:45 pm Saturday evening, and again from 7:00-7:45 am on Thursday, Friday, Saturday and Sunday. **These will be the only times available to you to load and test your presentation.**
- To avoid time delays and potential problems with your presentation, you will not be allowed to use your own computer.
- For the Macintosh users among us, please, be advised that you must save your presentation as .ppt, or more precisely *your name.ppt*. If the ".ppt" extension is not present in the file name, it will not be recognized on the PC show computer.
